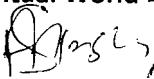

4. To discuss any other matters with the permission of the Chairperson.

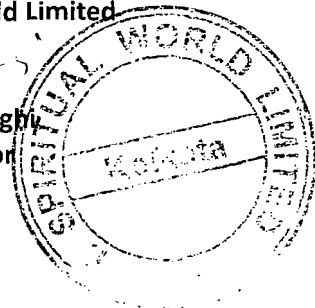

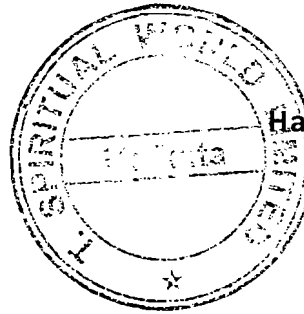
